- 4. Pre-bid meeting shall be held at Temkemaiyung Rural Municipality, Annapurna, Bhojpur at 14:00pm on 2080/09/22 (2024/01/07).
- 5. Electronic bids must be submitted to the office Temkemaiyung Rural Municipality, Annapurna, Bhojpur by e-bidding on or before 12:00 pm on 2080/09/29 (2024/01/14). Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00pm on 2080/09/29 (2024/01/14) at the office of Temkemaiyung Rural Municipality, Annapurna, Bhojpur. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security which shall be valid for 30 days beyond the validity period of the bid.
- 7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 8. The employer reserves the right to accept or reject wholly or partly any or all the bids without assigning any reason.
- 9. Any intimidation, collusion and cartelling during bidding process shall be punishable by law.
